THE SUPREME COURT (COMMERCIAL DIVISION) (FEES)
(AMENDMENT) RULES, 2016

In exercise of the power conferred upon the Rules Committee of the Supreme Court by section 4 of the Judicature (Rules of Court) Act, the following Rules are hereby made:—

1. These Rules may be cited as the Supreme Court (Commercial Division) (Fees) (Amendment) Rules, 2016, and shall be read and construed as one with the Supreme Court (Commercial Division) (Fees) Rules, 2002.

2. Paragraph 1(a) of the Schedule is amended by deleting from Column II in relation thereto the numeral "\$2,000" and substituting therefor the numeral "\$5,000".

THE RULES OF THE SUPREME COURT (FEES) (AMENDMENT), 2016

In exercise of the power conferred upon the Rules Committee of the Supreme Court by section 4 of the Judicature (Rules of Court) Act, the following Rules are hereby made:—

1. These Rules may be cited as the Rules of the Supreme Court (Fees) (Amendment), 2016, and shall be read and construed as one with the Rules of the Supreme Court (Fees), 2002 and all amendments thereto.

2. Paragraph A of the Schedule is revoked and the following is substituted therefor—
